- Village should make a concerted effort to bring up new facilities during all road projects (i.e. resurfacing projects and reconstruction projects).

Discussion included:

- Opportunities to provide public access to the Fox River Trail should be a part of every development discussion on Riverside Drive
- The trail users have increased dramatically as much as four times according to Brown County Parks Department counts between March, April, and May of 2019 and the same time frame in 2020. This increase is largely attributed to COVID-19.
- Daily passes for the Fox River Trail are not required at this time because of COVID-19.
