EXECUTIVE SUMMARY

2020 was a year that I'm sure none of us will ever forget. Personally, it was the most challenging year of my 38 year career. Thinking back to February of 2020 we started getting the first reports of a new "virus" and by March we were in the throes of an all-out global pandemic! This event was challenging for our department in many ways but I'm extremely proud of how our personnel (from the newest member right up to the senior ranks) responded to the crisis. The details of the effects, and our involvement in the response is detailed at the beginning of this report.

While dealing with the pandemic, we faced other obstacles including additional flooding events, civil unrest in the downtown area, and a major water main break at the Bellevue Retirement Center as well as all of the "normal" emergency responses that we routinely handle. While our call volume was down slightly (3.86 %) versus the previous year, our overall trend over the last 6 years has been an increase in emergency calls of 11% or 1322 emergency calls. The current year reduction was due, in most part, to the pandemic with many people working from home, reducing or eliminating unnecessary travel, homeschooling, and a general reduction in activities outside of home.

One of the major improvements in the department was the replacement of the entire Self Contained Breathing Apparatus (SCBA) equipment and air compressors. This was no small undertaking! Following approval from the Finance Committee and the full Council, approximately \$1,000,000 was earmarked in the Capital Improvement Program to replace the equipment in whole. Prior to this replacement, the equipment was piece-mealed which led to different versions of the equipment and various levels of life saving equipment, most of which was not up to date. SCBA is the single most important piece of equipment that firefighters use to protect their lungs form smoke, fire and heat during a fire and in many other circumstances as well.

In March of 2020, we were approached by the Village of Bellevue regarding the need for an Interim Fire Chief. Our team submitted a proposal along with another entity and we were successful in our bid. This led to discussions throughout the year between ourselves and the management and elected officials of Bellevue regarding the merging of the departments. Through countless hours of research, meetings and discussion, we were able to sign a Consolidation Agreement on November 13th, 2020 between the two communities that became effective on January 1, 2021. Long term, this will result in the elimination of duplicate administrative personnel, apparatus and equipment. We will provide a more efficient service at a reduced cost to all tax payers. It is our intention to continue these discussions with other entities when we are approached about the possibility.

Finally, a word about the need for capital investment in our facilities in the **NEAR FUTURE**. Referencing "Facilities" on pages 24 & 25 of this report, it should be noted that we have two stations (Station 1, 92 years old & Station 3, 85 years old) that are in

need of replacement. Both of these facilities have far exceeded their useful life and were built during a time when horses pulled steam fire engines. They are out of date, out of code and have serious deficiencies throughout the structures. Operationally they just do not fit our modern fire department, its members or the public. Serious planning must be given to replacing these building within the next 3-5 years. It would be our intention to eliminate Station 1 and build a new Station 3 with an administrative wing or floor somewhere in the Broadway District.

2020: The Year of COVID

As the news that COVID-19 had entered the United States spread, it quickly became clear that things were going to escalate rapidly in a short period time, changing how GBMFD would operate. Plans were immediately made to procure personal protective equipment (PPE) to keep our personnel safe as they would be on the front lines of the emerging pandemic. This included working with existing vendors, purchasing from local suppliers and manufacturers, and casting a wide net into as many other supply chains as possible. GBMFD would like to thank Prevea, Grainger, and Little Rapids Corporation for their assistance with testing and vaccinating our staff and procuring PPE. With their help, GBMFD was able to keep our staff properly equipped throughout the year and continues to have adequate supplies moving into 2021. When COVID-19 cases began to appear in the Green Bay area, a professional cleaning contractor was brought in to sanitize the departments six ambulances every day and as needed after transporting a COVID-19 To control sanitizing costs, GBMFD procured several sanitizing positive patient. machines that could be used for all apparatus and fire stations as needed. This allowed us to significantly reduce cost while increasing the frequency of cleanings to keep the public and our personnel safe.

Though GBMFD works with public health officials at different times throughout a normal year, the department identified the need to strengthen relationships and lines of communication with Brown County Public Health early on. We began meeting with public health and other EMS agencies on a regular basis to start planning for what was sure to come. GBMFD also began to meet virtually with other fire departments from around the state to gather and share information and best practices. These meetings quickly became daily occurrences in order to keep up with the constantly changing situation.

As the pandemic continued to escalate through the early days of March, multiple agencies needed to communicate and coordinate efforts. This included Public Health, Hospitals, Police, Fire, and EMS. To facilitate communication, coordination, and the flow of information the department activated the City of Green Bay Emergency Operations Center (EOC) on 3/14/2020, followed immediately by the activation of the Brown County Emergency Operations Center.



GBMFD was able to use many of its assets to assist in the regional response. The biggest asset relied upon was our people. More than 30 GBMFD staff assisted with various roles in the EOC. Some GBMFD personnel worked at the EOC continuously for several months. In the beginning several GBMFD retirees returned as volunteers to assist, guide,

and fill positions in the Incident Command System. GBMFD personnel who also serve as civilian soldiers in the Wisconsin National Guard (WING) were critical liaisons to the WING units that assisted with community testing at two locations, testing thousands of people. GBMFD played a large role in establishing and staffing the logistics section of the Incident Command structure. Logistics was responsible for supplying personal protective equipment to all agencies requesting assistance. Logistics' responsibilities included



supplying test sites, establishing a warehouse and distribution system for the PPE, feeding response personnel, and redistribution of PPE supplies to all municipal clerks in Brown County during the elections. GBMFD used personnel that had previous logistics experience through training with Wisconsin Task Force 1 and the local Incident Management Team. Retirees were again used to deliver supplies as needed throughout the County.

The COVID-19 pandemic taxed all parts of our systems and practices. It also forced us to establish new methods of operation and put our personnel in situations that they never experienced before. When coupled with flooding events and the civil unrest that occurred several times throughout the year, it was truly a year unlike any other.



DIVISION REPORTS OPERATIONS DIVISION

Assistant Chief Robert Goplin

The Operations Division of the Green Bay Metro Fire Department is tasked with protecting the lives and property of the citizens in our jurisdiction, which includes the City of Green Bay and the Village of Allouez. In early 2020, Green Bay Metro Fire Department also began managing operations for the Bellevue Fire Department. Overall, GBMFD personnel responded to 13,574 calls for assistance in Green Bay and Allouez.

The Operations Division is responsible for managing all emergency responses and requests for assistance that come to the department through the Brown County Public Safety Communications Center. These calls for assistance cover many disciplines, all of which require specialized training for all personnel. The department responds to and trains for EMS, Fire, Hazardous Materials, Water Rescue, Rope Rescue, Collapse Rescue, Trench Rescue, Carbon Monoxide, and general assistance incidents.

RESPONSE DATA

Call volume for 2020 decreased by slightly less than 4% from 2019. The global COVID-19 pandemic initially caused a decrease in responses due to significantly decreased social activity and employers adopting "work from home" policies. However, the overall trend continues to demonstrate an increase in incident volume from year to year. EMS continues to be the primary need that the department responds to. While fires are a smaller percentage of responses, the economic impact of fires is significant. An unchecked fire can cause millions of dollars in damage in a short period of time which is why a quick and efficient response is vital.
