AWARD OF CONTRACT FOR RECONSTRUCTION PROJECT PHASE 2A

Bids were received on March 21st for the sewer and water replacement on the Hoffman Road project and for Clay Street reconstruction including Waubenoer Drive sanitary sewer and the remaining portion of Hastings Street. The low bidder was De Groot Construction.

The estimated cost of the project was \$2.57 million, and the low bid was \$2,525,131.21.

It is recommended that the contract be awarded to De Groot for the base bid amount of \$2,525,131.21.

The alternate bid item for Park Front Way will be decided, if to be implemented, based on review of the overall project budget including the street reconstruction costs for Hoffman Road and the paving bid to be received for Somerset and Hilltop. With the utility replacement bid in hand we will review the overall project budget versus the proposed bond.

The non-conforming bid for Peters Concrete is due to the bid form not being filled out completely due to leaving out the written cost of each bid item. This was the second low bidder but since it was not the low bid we did not pursue whether this bid would be acceptable.
