Attached are the proposed ordinance changes to meet the new Floodplain requirements as required the Federal Emergency Management Agency. The changes must be in place by March 17, 2014.

In order for us to remain compliant with the minimum requirements of the National Flood Insurance Program and Chapter NR 116, Wisconsin Administrative Code, the village ordinance must be amended to include the revised FIS number and effective date and be approved by the DNR and FEMA no later than March 17, 2014.

We have been and will continue working with Gary Heinrichs from the DNR to complete the process as required.

Village Board is asked to approve Ordinance 2014-04 to remain in compliance.

ORDINANCE NO. 2014-04

**AN ORDINANCE AMENDING SECTION 1.5(2) OF CHAPTER 10, FLOOD PLAIN ZONING,
OF THE VILLAGE OF ALLOUEZ MUNICIPAL CODE RELATING TO OFFICIAL MAPS AND REVISIONS**

The Village Board of the Village of Allouez, Brown County, Wisconsin, does ordain as follows:

SECTION 1. Sections 1.5(2), Official Maps & Revisions shall be amended to read as follows:

(2) OFFICIAL MAPS & REVISIONS

The boundaries of all floodplain districts are designated as floodplains or A-Zones on the maps listed below and the revisions in the Village of Allouez Floodplain Appendix. Any change to the base flood elevations (BFE) in the Flood Insurance Study (FIS) or on the Flood Insurance Rate Map (FIRM) must be reviewed and approved by the DNR and FEMA before it is effective. No changes to regional flood elevations (RFE's) on non-FEMA maps shall be effective until approved by the DNR. These maps and revisions are on file in the office of the Zoning Administrator, Village of Allouez. If more than one map or revision is referenced, the most restrictive information shall apply.

OFFICIAL MAPS:

Based on the Brown County Flood Insurance Study (FIS), dated (~~August 18, 2009~~ March 17, 2014), Volume number 55009CV001AB, 55009CV002AB and 55009CV003AB

SECTION 2. All ordinances or parts of ordinances, in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall take effect upon its adoption and publication.
