WATERMAIN REPLACEMENT PROJECT PHASE 2 WDNR FUNDING STATUS SDWF Project No. 5325-03

Project

This is the water main replacement project that was authorized in 2013 for development and submittal to the WDNR for possible funding as a future project. This project is intended to replace the water mains on 10 residential streets which have water mains are in poor condition and the highest priority for replacement.

Project Funding

The Village engineering staff prepared the construction plans and financial assistance application and submitted these to the WDNR by June 30, 2014. The priority ranking score for this project, typical for water main replacements, was a score of 37. This is very low with many projects ranking higher (more than 100 projects). It was believed this project would not be funded for several years due to the low priority ranking.

Due to the limited number of project submittals by June 30th the WDNR has notified Allouez that the project will be funded (see the attached letter). To receive the low interest loan funding the project must be bid, the construction contract awarded, and the WDNR financial assistance agreement signed by June 30, 2015. This makes this a 2015 construction project with completion in 2016.

Project Cost and Rate Impact

The project is an approximate \$2,400,000 project. The interest rate is 1.925% but could change slightly by loan closing. The debt service for this SDWF loan will be a little bit less than \$145,000 per year and would be in effect in 2016. For the approximate 5,500 customer meter equivalents the fixed monthly charge for this debt in 2016 will be about \$2.00 per month for a residential water meter.

The Water Utility should complete a Public Service Commission (PSC) rate review in parallel with the project to incorporate the new debt service into the water utility rates. Also it has been more than five years since the last PSC rate review. Schenk will be involved in the PSC rate case and in determining if a 2015 or 2016 rate submittal.

Project Considerations

Reasons to proceed with this project:

- 1. Obtaining the loan for this project is an opportunity—a low project priority score would usually not result in SDWF funding. This opportunity might not happen again as more communities decide to proceed with projects in the future (as the economic conditions improve).
- 2. These are the highest priority water main replacements in the Village at this time. Ten streets will be improved (water mains and partial street paving).
- 3. There will be cost savings due to a reduction in losses of purchased water and water main repairs.

Concerns about this project:

- 1. The project results in a water utility rate increase in 2016 of \$2 per month per residential customer.
- 2. The project requires a staff commitment for field observation during construction, which increases workload at the same time as the water meter replacement project.

Overall this project makes sense to proceed as it continues to improve the Village water system and replace aging water mains that need replacement.

This is probably the last major water main only project that the Village will implement.

The Department received and reviewed your application for financial assistance and determined your project is eligible for funding according to the requirements of s. NR 166.10, Wis. Adm. Code.

The SDWLP will publish a <u>draft</u> Funding List for SFY 2015 in the near future at http://dnr.wi.gov/Aid/LoanNews.html. The final SDWLP Funding List will identify which projects fall within the fundable range for loan monies and principal forgiveness funds. At this time, it appears we have enough loan monies available to fund all SFY 2015 applications received, but not enough principal forgiveness funds available to offer to all. The final funding list will replace the draft on the Environmental Improvement Fund's (EIF) web page most likely early in the fall.
