Background Information:

Replacement of Fleet #37 - 2007 Jacobsen HR-9016 Mower

The Parks, Recreation, and Forestry Department is requesting authorization to replace a 2007 Jacobsen HR-9016 turf mower. This equipment is used by the Parks Department primarily for large area mowing of parks and athletic fields. It has served the department well and provided for efficient operations due to its larger cutting width of 16 feet. Our mechanic staff has had good luck with this manufacturer and the ease of maintenance and availability of repair and replacement parts.

This mower is currently 9 years old with 3308 hours and has a typical useful life of 8 years in the municipal environment. It was previously approved by the Board for replacement in the 2016 Capital Improvement Plan equipment replacement budget.

A local distributor for Jacobsen turf equipment, Horst Distributing from Chilton, is providing a 2015 demo unit for sale in 2016 for \$8625 less than the quoted price for a new 2016 unit. This demo unit has 48 hours on it from municipal and school district site demonstrations and is in excellent shape. We need to make a decision on acquisition of the demo unit as soon as possible as other parties are interested in it as well. The actual MSRP for a new Jacobsen 2016 HR-9016 is \$139,000.

Budget Information:

This piece of equipment has been approved in the 2016 equipment replacement budget at \$75,000 to come from the Equipment Replacement Fund.

The Parks Department will not take delivery of the mower until April thus will not be invoiced until then. In the mean time staff will attempt to sell the 2007 mower outright or on an auction website and expects to receive \$25,000 to \$30,000 with the option to always return to the vendor and receive the listed trade value. Funds received from sale of the used equipment would go into the equipment replacement fund.

Staff Recommendation:

Staff recommends that the Village Board authorize the purchase of the 2015 Jacobsen HR-9016 demo unit not to exceed a price of \$79,870.00.
