The Purpose

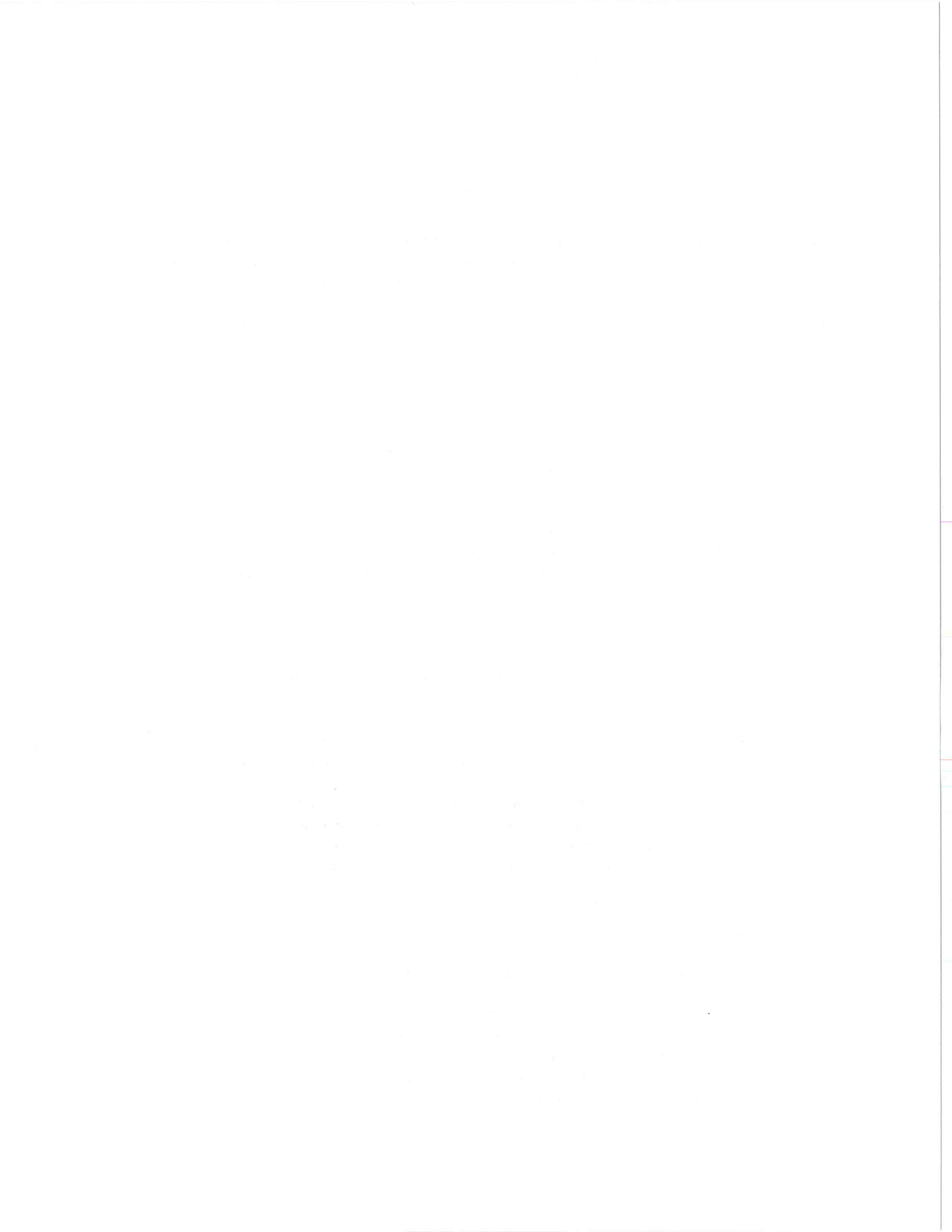
- The mission of the NEW EYE program is to unite the P.E.G. channel resources of Brown County to:

The Benefits

- NEW EYE will have a significant effect on all municipalities whether through Cost Savings, Community Investments, or Communication Opportunities
 - NEW EYE will showcase Brown County communities and assets to economic markets across the state and nation to attract new businesses to the area and create family-supporting jobs
 - NEW EYE will provide municipalities unprecedented access to high-quality production facilities at deeply discounted rates
 - NEW EYE will give constituents increased access to their local governments by offering on-demand and live viewings of municipal meetings options, as well as PSA's highlighting municipal services for residents
 - NEW EYE will restore local involvement and programming in community television
 - NEW EYE will assist communities by acting as a media and marketing resource

The Operations & Funding

- NEW EYE is projected to cost approximately \$140,000 annually for operations, including most costs of video production.
 - Primary Funding Source: Municipal Funding (Cable Franchise Fees)
 - The primary coverage of the NEW EYE program will come from a contribution by municipalities from the Cable Franchise Revenues
 - Remaining costs will be covered by a combination of corporate sponsorships, grants, private donations, and self-generating revenue

What is NEWEYE?

NEWEYE Purpose: To unify local government communication throughout Brown County by providing a centralized, non-profit management of municipal Public, Education and Government (P.E.G.) TV channels, while still maintaining each community's individuality.

NEWEYE Mission: To increase **Government Transparency**, promote **Local Culture**, and provide municipalities with an additional **Economic Development Tool** for business recruitment and job creation.

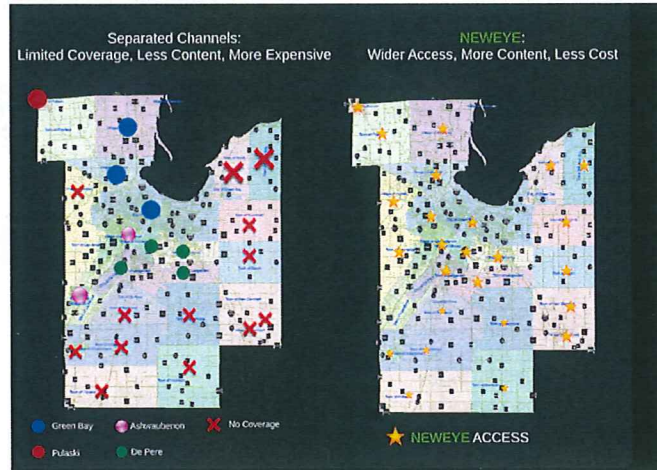

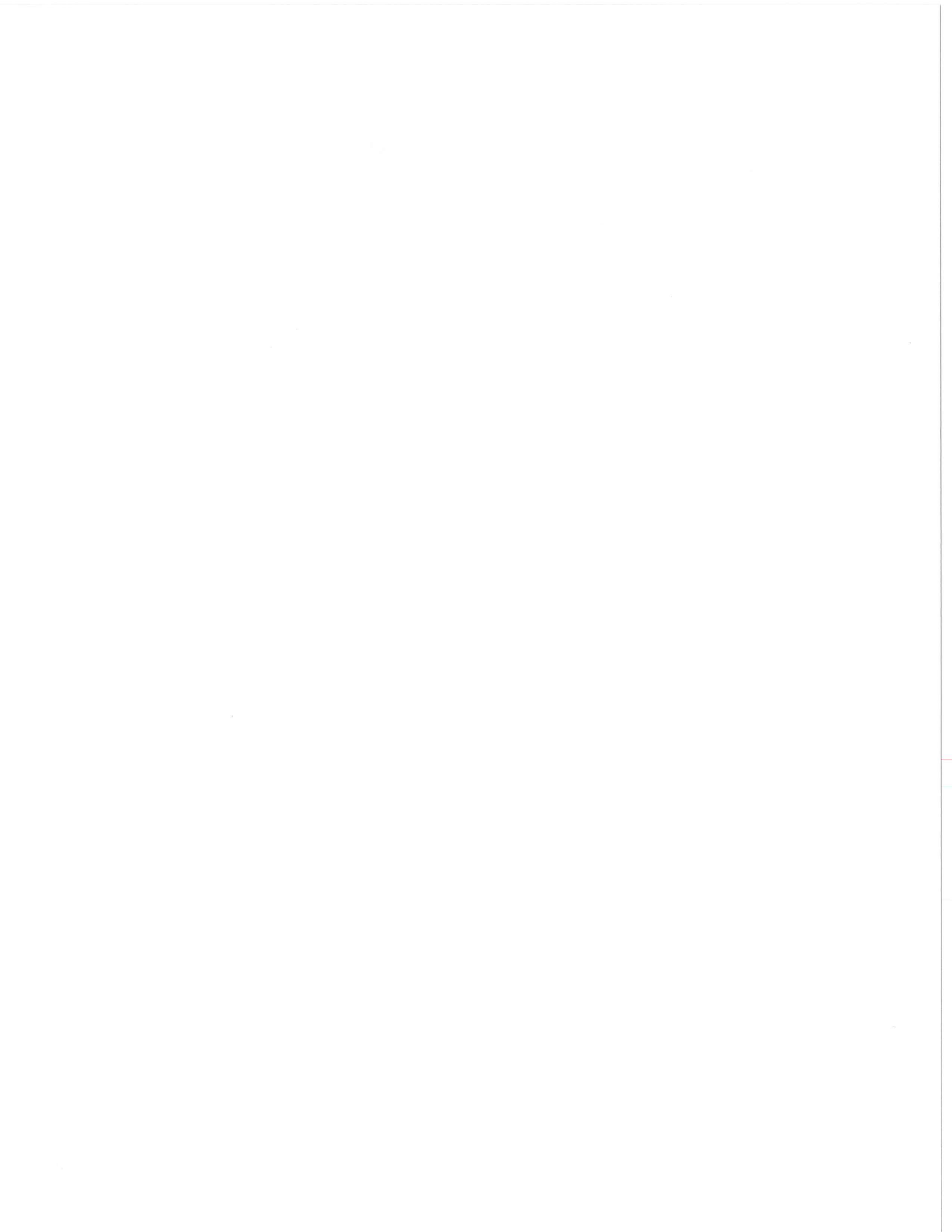

What are the Costs?

- Operational costs are figured at approximately \$140,000 annually
 - The primary coverage of this cost will come from a contribution of by municipalities from their Cable Franchise Fee revenues
 - Remaining costs will be made up from a combination of corporate sponsorships, grants, private donations, and self-generating revenue.
- Unlike most P.E.G. stations, **NEWWEYE** will have a special contract with a local production station that will provide heavily discounted rates to **NEWWEYE** member municipalities

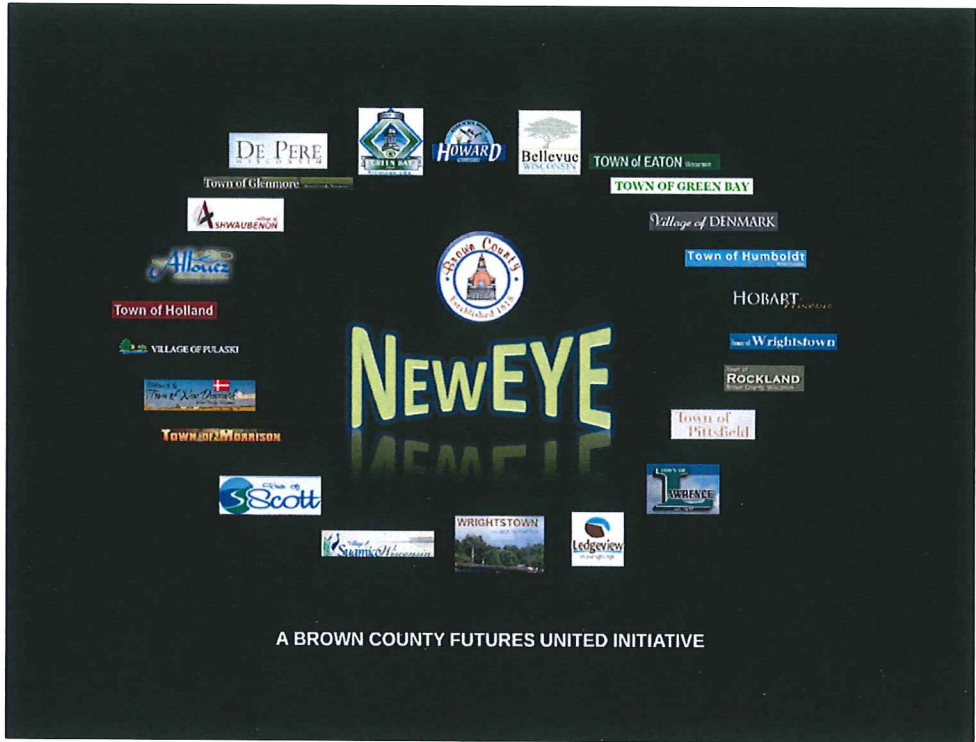
The Benefits of Cooperation (SIPOS)
