DISCUSSION OF THE MAY 10TH OPEN HOUSE FOR NATIONAL REGISTER ELIGIBLE HOMES

The committee provided a summary of the open house that took place on May 10th

- Event turnout about 30 people, with a good representation from the eligible Robinson Hill Historic District.
- Wisconsin Historical Society (WHS) presented a plaque to the village, recognizing the listing of the Pump House on Greene Avenue and the former Water Department Building (Community Center) on Webster Avenue to the National Register of Historic Places.
- A representative from WHS gave a presentation on the benefits and myths of listing a property to the National Register.

ACTION RE: SELECTION OF ROBINSON HILL RESIDENTIAL HISTORIC DISTRICT FOR DISTRICT KICKOFF MEETING

Staff explained that a district kickoff meeting is required in order to submit a letter of intent for the Certified Local Government (CLG) grant in September. If the committee wishes to move forward with the eligible Robinson Hill Historic District for the next grant cycle, staff will mail out an invitation to all of the property owners. The number of property owners that attended the open house shows a positive interest from this eligible district, but staff suggests not moving forward unless a larger interest is shown.

Motion by Fredericks / Mooney to have a "District Kickoff Meeting" on June 22nd to gauge interest to move forward for a potential National Register nomination of the eligible Robinson Hill Historic District and individually eligible homes. Motion carried.
