

ORDINANCE NO. 2016-07

AN ORDINANCE AMENDING SECTIONS 26.10A AND B OF CHAPTER 26, FENCES, RELATING TO THE NUMBER OF DAYS IN WHICH FENCE REPAIRS ARE REQUIRED TO BE CORRECTED

SECTION 1. The Village Board of the Village of Allouez, Brown County, Wisconsin, does ordain that Sections 2610A and B, be amended to read as follows:

26.10 MAINTENANCE OF FENCES.

- A. Every fence shall be maintained free of structural impairment and major surface defects or shall be removed at the fence owner's expense. Repairs required to correct any such deficiency shall be performed within ~~90~~ 30 days from the date of damage.
- B. Every fence shall be maintained free of minor structural impairment and minor surface defects or shall be removed at the fence owner's expense. Repairs required to correct any such deficiency shall be performed within ~~30~~ 15 days from the date of damage.
- C. Hedges shall be trimmed or confined to the property on which they are planted.

SECTION 2. All ordinances or parts of ordinances, in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall take effect upon its adoption and publication.
