Re: ACTION RE: CONTINUING SERVICES AGREEMENT WITH GRAEF FOR CREATING A CONCEPT DESIGN FOR THE REDEVELOPMENT OF THE WEBSTER AVENUE AND ST. JOSEPH STREET INTERSECTION

Date: 15 July 2016

The Village Board adopted the Riverside Drive and Webster Avenue Corridor Study as part of our Comprehensive Plan in the fall of 2015. In this planning study, it calls for the redesign of the Webster Avenue and St. Joseph Street intersection and the development of an "Arboretum Trail" along the north side of St. Joseph Street. These infrastructure improvements are meant to facilitate the desired development for that area of the village by showing a "buy-in" from the municipality in the development plans and by creating "curb appeal" for a stretch of corridor in need of redevelopment.

The next step in this process is to come up with a concept design of the roadway, streetscapes, and other improvements in order to begin the engineering process and develop project costs. GRAEF has provided the Village with an estimate of \$16,513 for the development of a concept design for Webster Avenue between Miramar Drive and Beaupre Street (see attached).

The timing of this concept design is important, as a portion of St. Joseph Street is scheduled to be reconstructed in the next few years, and with the delay in the STH57/Riverside Drive reconstruction project, the portion of Webster Avenue highlighted in the attached services agreement could also become a near future project.

This project area does lie within TID#1 and the project can be classified as a TIF eligible expense. Staff recommends using TIF funds for the completion of this phase of the project.

The Village Board is asked to approve staff to enter into a continuing services agreement with GRAEF for creating a concept design for Webster Avenue between Miramar Drive and Beaupre Street.
