Re: AWARDING OF FAÇADE IMPROVEMENT GRANT

Date: June 30, 2016

The village has received an application for the Façade Improvement Program from Lutsey Enterprises for their commercial property at 1329 S Webster Avenue (Los Magueyes). Lutsey Enterprises is requesting a Façade Improvement Grant to help fund building façade improvements to the site. Attached is the project narrative for the site. Below is a summary of the project, which includes the scope of work.

Scope of project:

- Addition of galvanized metal panels around the overhang on the south and west faces of the building.
- Addition of LED lighting to the soffit.
- Addition of reclaimed wood around the west entrance.
- Remove and replace door on the south entrance.

Anticipated start date: July 5, 2016

Anticipated completion date: July 29, 2016

Estimated project cost: \$20,048

Requested assistance: \$10,000 in grant funds

The project will have to comply with all applicable village zoning and development requirements, the project will have to be completed within one year of grant approval, and no work begun prior to receiving Village Board approval will be eligible for reimbursement.

The Village Board is asked to review the project and determine whether or not to allocate funds to reimburse for up to 50% of the eligible project cost, not to exceed \$10,000.
