Duck or Fowl Ordinance

To: Administer Lange

From: Code Enforcement Officer Lauder

Reference the Ordnance's on fowl. I checked the surrounding Cities and Villages on what they have.

- City of Green Bay: allows chickens, Pigeons (for racing only) pet birds are Finches, dove, parrot, canary, parakeet, conure, cockatiel or cockatoo. Restricted were geese and ducks.
- City of Depere: allows only chickens prohibited were ducks, geese, and turkeys.
- City of Appleton: allows chickens, pigeons by permit. Restricts geese and ducks or other fowl.
- Village of Hobart: restricts any poultry, pigeons or fowl.
- Village of Suamico: allows keeping of chickens
- Village of Howard: allows chickens and poultry including pigeons are allowed in the rural estate and agricultural districts. Chickens are allowed in the residential destricts.

- Village of Ashwaubenon: Only allows chickens (must receive written approval from all neighbors within 100 Ft of property)
- Village of Bellevue: Only allows chickens
- Town of Lawrence: Only allows chickens in Residential and Estate Residential min size lot of 1 acre. Must have neighbor's approval.

The only city that I found that would allow ducks was the City of Neenah. They have a large ordinance on a variety of different fowl that are allowed. Their only restriction is that no more than 4 fowl at a residence.

Some of the other cities that we check that didn't allow fowl were Sheboygan, Milwaukee, Burlington and Franklin.

Sec. 3-3. - Keeping of fowls.

(a)

No person shall keep or harbor any chickens, doves or other fowl or build, erect or maintain and use any chicken coop or yard, dove cote or other building or yard to keep or house any chickens, doves or other fowl anywhere within the City without registering the name and address of the owner and the approximate number of chickens, doves or other fowl to be kept by such owner at the Office of the Building Inspector. The total number of chickens, doves or other fowl shall not exceed four per premises.

(b)

All chicken coops and yards, dove cotes and other buildings or yards wherein any domestic animals are contained shall be kept in a clean, sanitary condition and free from all objectionable odors and shall be subject to the inspection and approval of the Building Inspector. Approval shall be given upon a showing that such facilities are clean, in sanitary condition and free from all objectionable odors.

(c)

Chicken coops and yards, dove cotes and other buildings or yards permitted under this section shall be limited to the keeping of up to a total of four chickens, doves, poultry or fowl per property, and shall be subject to the following conditions:

(1)

The principal use of the property where a chicken coop and yards, dove cotes and other buildings or yards may be permitted is limited to single-family dwellings.

(2)

No person shall keep any rooster.

(3)

No person shall slaughter any chickens, doves, poultry or fowl.

(4)

The chickens, doves, poultry or fowl shall be provided with a covered enclosure and must be kept in the covered enclosure or a fenced enclosure at all times.

(5)

No enclosure shall be located closer than 25 feet to any residential structure on an adjacent lot and shall not exceed 25 square feet unless permitted as an accessory building.

 - o Will be enclosed and include green scape
 - o Plans to start on Tuesday if approved
- Had numerous requests to create a music venue
 - Provide a daytime outdoor venue with great entertainment from 2 6 p.m. on Sundays in their parking lot

Substitute motion by Rafter / Genrich to approve a process where we invite the resident with the ducks to petition the neighborhood or share the information with the neighborhood and see if he can get support from the neighbors at which time we could do it on a conditional use basis.

Discussion:

- Don't pit neighbor against neighbor.
- There is an ordinance in place, respect the process.

Green / Dart moved to open the meeting for public comment. Motion carried.

Tim Voelker

- Neighbor on the other side has no problem with the ducks and no other neighbor can see them.

Jim Orourke, 2339 Oakwood Avenue

- If you are going allow ducks, look at all the animals you are going to let in and come up with one comprehensive plan.
- Look at restrictive covenants that are put in different neighborhoods around the State.

Judy Poh, 2375 Riverside Drive

- Spent a summer with 24 wild turkeys in her yard and survived very well. They didn't stink.
- Since the yards are next to each other, maybe they could position the ducks facility farther away from the neighbors.
- Doesn't think the ducks are going to cause any long term problems any more than a neighbor with 3 unruly children.

Atwood / Harris moved to return to regular order of business. Motion carried.

Substitute motion by Atwood / Sampson to give Mr. Voelker two weeks to transport the ducks back to his uncles farm, we will put back on the agenda as an action item and discuss further on rewriting the ordinance to allow ducks or not to allow ducks. Motion carried.
