SUPPORT OF NEW WATER'S ADAPTIVE MANAGEMENT PLAN

NEW WATER is proposing to use Adaptive Management compared to expensive plant upgrades to meet DNR water quality standards. The use of Adaptive Management will cost approximately 38 million dollars over the next 30 years compared to 98-million-dollar plant upgrade.

NEW WATER, with help from a number of stakeholders, just recently completed an adaptive management plan in the Silver Creek Watershed. The pilot study started in 2014 worked with landowners and farmers to install conservation practices that included buffers strips, wetland restorations, grassed waterways and the placement of cover crops. Monitoring of the downstream waterways did show an improvement in water quality and supports the use of Adaptive Management.

Due to the success in the Silver Creek Watershed, New Water plans to complete an Adaptive Management plan in the Ashwaubenon and Dutchman Creek Watersheds over the next 20 years. New Water is asking its customers to provide a letter to them supporting their Adaptive Management plan. NEW WATER has provided a letter for communities to use to support the plan. The letter has been included with this staff report.
