2019 Reservoir Inspection Proposal Summary

Early in March the Village of Allouez and City of De Pere jointly requested proposals from contractors to perform the inspection of water storage reservoirs in each community. The Wisconsin Administrative Code requires the inspection of water storage facilities every 5-years. The Code requires a dry inspection of the interior every 10-years. The following Village Reservoirs are being proposed for inspection under this proposal.

- o 141 VanDeHei Road Reservoirs are 300,000 and 800,000-gallon underground storage reservoirs. The interior of the reservoirs for this inspection will require at a minimum a wet inspection.
- 3211 Libal Street Reservoir is a 250,000-gallon underground storage reservoir. The interior of the reservoir for this inspection will require at a minimum a wet inspection.
- o 821 Dauphin Street Reservoir is a 250,000-gallon underground storage reservoir. The interior of the reservoir for this inspection will require at a minimum a wet inspection.
- 717 Kalb Street Reservoir is a 250,000-gallon underground storage reservoir. The interior of the reservoir for this inspection will require at a minimum a wet inspection.
