ACTION RE: 2019 SENATE BILL 314

Staff discussed the 2019 Senate Bill 314 that is being circulated currently. The bill is specifically written towards a community in the Milwaukee area, but historic preservation advocates fear it could be a precedent for removing local control of historic properties.

No action was taken at this time.

DISCUSSION RE: SUNLIGHT PARK NEIGHBORHOOD PICNIC

Staff put together a brochure using the history of the Sunlight Park Neighborhood written by Ropp. The brochure was distributed at the annual neighborhood picnic. The information was also published in the Historic Allouez Society newsletter. The committee commented on the good turnout of the picnic, the interest by the residents in the history of the neighborhood, and the good collaboration with Historic Allouez Society.

DISCUSSION RE: PROJECTS AND PROPERTIES UPDATE

Staff stated that the nomination for the Robinson Hill Historic District has been submitted to the State Historic Preservation Office. However, the nomination will likely not be reviewed by the State Historic Preservation Review Board for several more months.
