§ 302-5: The use of sound amplifiers outside buildings within the Village of Allouez is prohibited without a permit to do so from the Village. The Village shall not grant a permit to use a sound amplifier during nighttime hours (10:00 p.m. to 7:00 a.m.) or to operate such sound amplifier in the vicinity of health facilities, churches while services are being conducted, or schools which are in session. The Village may order a reduction in the volume of such sound amplification on complaint being made by a citizen or when such sound amplification is a nuisance because of the volume, the method in which it is being used, or the location in which it is being operated.

Vogel, spoke with Riviera Bar and Grill owner Mari O'Brien in person at 2150 Riverside Dr. Mari has recently completed a Noise Variance Permit Application for small music events on their patio on the days from Thursday to Sunday during the summer and fall of 2021. These music events on their outside deck would be from the hours of 3pm to 10pm. The noise generating equipment that will be used are speakers for the music.

Mari reports she has completed this application in the past but has not had an opportunity to have live music on their patio. Mari reports she has no music booked at this time but would like to pursue this in the very near future. Mari states they will point the speakers towards the Fox River and will be on hand with her cell phone as a contact if police have an issue.

There are no residential buildings neighboring this property as the Mariner Motel is currently empty. A search of this property shows no recent noise complaints. At this time I am recommending approval of this application.
