Sandlot youth baseball tournament to support their Sluggers baseball program. This tournament brings in teams from throughout Wisconsin.

Background Information:

The Green Bay East Side Youth Baseball organization has been utilizing the fields at PH Martin Webster Park for the past three seasons for their youth baseball league and tournament. Last season they requested to sell beer at the Sandlot youth baseball tournament. Village policy does not allow for the sale or consumption of alcohol at PHM Webster Park without Board approval. The Parks, Recreation, and Forestry Committee recommended approval to the Village Board at the February 25, 2020 meeting with the following conditions:

- Approval to sell on the second weekend was dependent on no issues occurring during the first weekend (last year they had planned for splitting the tournament into two weekends which ultimately was held only one weekend due to COVID 19).
- The organization was to provide a security officer on site at the organizations expense.
- The request was to be brought back to the Committee annually for approval.

The Village Board took up the request at the March 3rd, 2020 meeting. The request was granted with the conditions as recommended by the Parks, Recreation, and Forestry Committee.

The organization abided by the conditions that were set forth and staff had heard of no issues during the 2020 Sandlot tournament.

Previous Information/Action:

June 22, 2021 - The Allouez Parks, Recreation, and Forestry Committee recommended approval of the request to sell beer at the tournament with the same conditions as previously required.
