#### 2021 MS4 STORMWATER ANNUAL REPORT TO WDNR

#### S. Gehin:

- Pursuant to NR 216.07(8), Wis. Adm. Code, an owner or operator of a Municipal Separate Storm Sewer System (MS4) is required to submit an annual report to the Department of Natural Resources to report on activities for the previous calendar year.
- Gehin gave an overview of the requirements necessary to comply with the permit. Supporting documents were completed and submitted with the report.
- Some of the notable stormwater activities completed by the Village in 2021 included:
  - All About Allouez booklet, Village webpage and partnership with Northeast Wisconsin Stormwater Consortium (NEWSC) were utilized to inform and educate the general public on a number of stormwater related topics.
  - Hired McMahon Associates to inspect a portion of the Village's storm sewer outfalls for illicit discharges (any substance discharged into our storm sewer other than clear water).
  - o Village owns seven ponds and the ponds provide stormwater treatment and storage.
  - Street sweeping (collected 117 tons of material)
  - o Fall clean-up (5 full trips around the village)
