### **Background Information:**

The Green Bay East Side Youth Baseball organization has been utilizing the fields at PH Martin Webster Park for the past four seasons for their youth baseball league and tournament. For the last several years they have requested to sell beer at the Sandlot youth baseball tournament. Village policy does not allow for the sale or consumption of alcohol at PHM Webster Park without Board approval. The Parks, Recreation, and Forestry Committee recommended approval to the Village Board in 2020 and 2021 with the following conditions:

- The organization was to provide a security officer on site at the organizations expense.
- The request was to be brought back to the Committee annually for approval.

The Village Board has granted the request for the past two years with the conditions as recommended by the Parks, Recreation, and Forestry Committee.

The organization has abided by the conditions that were set forth and staff had heard of no issues with regards to beer sales during the tournament.

## <u>Previous Information/Action:</u>

May 24, 2022 - The Allouez Parks, Recreation, and Forestry Committee recommended approval of the request to sell beer at the 2022 tournament with the same conditions as previously required.
