

§ 302-5: The use of sound amplifiers outside buildings within the Village of Allouez is prohibited without a permit to do so from the Village. The Village shall not grant a permit to use a sound amplifier during nighttime hours (10:00 p.m. to 7:00 a.m.) or to operate such sound amplifier in the vicinity of health facilities, churches while services are being conducted, or schools which are in session. The Village may order a reduction in the volume of such sound amplification on complaint being made by a citizen or when such sound amplification is a nuisance because of the volume, the method in which it is being used, or the location in which it is being operated.

Austin had completed this form for a backyard patio/birthday party he will be hosting on Friday, September 16th, 2022, at his address of 337 Coolidge ST. Austin reports he is expecting approx. 30 people at this event. Austin's request is for amplified music by a 3 piece acoustic band in the backyard area. Austin is requesting the time of operation from 5pm to 10pm but believes the acoustics will be completed by 9pm.

I spoke with Austin about pointing the speakers west towards the river and north towards the Green Bay Correctional Institution. Austin agreed. Austin states he has invited his next neighbors to the party. Austin verified his contact information in case someone would need to be contacted on this day if complaints are made.

Currently, I am recommending approval of this application.
