AMENDMENT NO. 1 OF LIBAL STREET ENGINEERING AGREEMENT S. Gehin

- Primary reasons for amendment to the Libal Street Engineering Agreement are as follows:
 - o Amend pavement design report between Allouez Ave & Kalb Ave. to reflect a mill and overlay as opposed to pavement replacement.
 - o Alignment shift between STH 172 & Allouez Ave.
 - Review of 9 curb ramp locations for ADA compliance.
 - Assist with the review of existing storm sewer lateral locations between Hwy 172 to Allouez Ave. and assistance with on-site review of the condition of storm sewer structures between Allouez Ave & Kalb Ave.
 - Relocation of sidewalk encroachments between Allouez Ave. & Kalb Ave. to avoid purchasing permanent right-of-way (number of parcels increased from 85 to 109).
- Amendment in the amount of \$57,771.82 will increase the original engineering agreement cost from \$532,711.62 to \$590,483.44. Federal Surface Transportation Block Grant received for the project will reimburse the village up to 80% of the design and construction.

Discussion:

- Work with Brown County Planning Commission on proposed changes? (Gehin will look further into.)
- Original agreement was signed May 20, 2021. Strand Associates annual employee increases are included in the amended agreement. Does the village have to pay the difference? (Gehinyes)

Genrich / Atwood moved to approve amendment No. 1 of Libal Street Engineering Agreement and to work with Brown County Planning Commission if any changes need to be discussed. Motion carried.

EASEMENT AGREEMENT FOR UNDERGROUND PRIVATE UTILITIES BETWEEN THE VILLAGE OF ALLOUEZ AND WISCONSIN PUBLIC SERVICE CORPORATION FOR PARCEL AL-50-10 (1905 S. Webster Avenue)

T. Fuller:

- Working with WPS and the developer for the Velay apartment project at 1905 S. Webster Avenue regarding the necessary easements (1 of 6) to bury existing overhead utilities.

- Harris questioned wording for #6, exercise of rights. Fuller will confirm with the village attorney whether it is standard language or requires updating.
