- a. Resignation of Danyelle Pierquet, Parks, Recreation & Forestry Committee
  - President Rafter stated that the Village of Allouez through Project Vote had the highest voter turnout with 78% of residents participating.
  - Trustee Harris provided updated information on the New Water budget presentation from October 4<sup>th</sup> Board Meeting.
    - o NEW Water's proposed 2023 budget would equate to the typical Allouez household seeing an overall increase in their 2023 monthly/sewer bills of a little under 2.25%.

# **ADOPTION OF 2023 BUDGET**

### Discussion

Harris / Green moved to adopt the 2023 Budget with a tax rate of \$6.433 per thousand dollars of assessed value and the transfer of \$90,000 of fund balance to account for the 2022 expenditure restraint and the transfer of \$16,000 to off-set the increase from Green Bay Metro. Motion carried.
