The list of American Rescue Plan Act projects that were recommended by the standing committees were presented to the Village Board. Staff is now going through the list of projects and will present a refined list to the Village Board.

## DISCUSSION RE: UPDATE REGARDING EFFORTS IN SUPPORT OF DECOMMISSIONING GREEN BAY CORRECTIONAL INSTITUITON

Staff provided the following update:

- The Village of Allouez continues to work with Platform Communications for marketing and communication strategy for the decommissioning of Green Bay Correctional Institution.
- President Rafter and Brad Lange met with the Secretary Carr from the Department of Corrections as well as representatives from Governor Evers' Administration, with the aim of having the decommissioning of GBCI in the State Biennial Budget.

Discussion included:

- Emergency services costs incurred as a result of the facility.
- The likelihood the state will build a new facility versus relocating the inmates to an existing facility.
- Estimated timeframe for building new versus relocating inmates.

## DISCUSSION RE: VILLAGE OF ALLOUEZ SESQUICENTENNIAL

Staff provided the following update:

- The Village of Allouez celebrates the community sesquicentennial (150 years anniversary) in 2023.
- Planned activities include:
  - Village Board meeting at the original Town Hall at Heritage Hill.
  - Band and celebration event later in the summer, with the possibility of fireworks.
  - Updated street banners.
  - Business support and recognition from other community events throughout the year.

The suggestion was made to improve the historical marker sig on the Fox River Trail to reflect the new milestone.
