Background Information:

The Village Parks, Recreation, and Forestry Department put out a Request for Proposals (RFP) to furnish and install surveillance cameras in seven parks and the Lebrun yard waste site. These cameras will help reduce vandalism and provide video records of incidents if needed. The project is to be completed by the end of December of this year.

The project site locations, proposed number of cameras, and viewing capabilities are listed in the following table.
