- Nyberg announced that the Green Bay Public School District will be applying for Safe Route to School funding to adopt a system-wide plan.

PUBLIC APPEARANCES

- Commented on:
 - Temporary crosswalks on Riverside Drive
 - Sidewalk and pedestrian accommodation requirements as part of recent development projects

Megan Pfarr, 3230 Tam O'Shanter Court

- Concerned with the rear portion of the village-owned land at 3245 Riverside Drive

DISCUSSION ON ROUNDABOUT SAFETY (DEO J. Vogel)

DEO Vogel participated in discussion regarding pedestrian safety at roundabouts, specifically the roundabout at the intersection of Libal Street and Hoffman Road.

Discussion included:

- Flashing light at crosswalks in school zones
- Rumble strips or textured crosswalks
- Colored crosswalks
- Crossing flags
- Increase pedestrian activity
- Education opportunities

The committee agreed that this topic should be included in the plan and further research should be done on what is being done in communities outside the area.

ACTION RE: APPROVE PLAN GOALS

The committee discussed defining each goal and moving the bulleted items to the "Strategies" section.

The committee will continue discussion at the next meeting.

DISCUSSION OF ALLOUEZ COMPREHENSIVE BICYCLE AND PEDESTRIAN PLAN DRAFT

The committee discussed the draft Comprehensive Bicycle and Pedestrian Plan and updated timeline.

Discussion included:

- Education programs and opportunities (e.g. bike rodeos at summer youth programs)
- Policies that are used for paying for sidewalks special assessments, part of road construction cost, or by developers
- The "Arboretum Trail" defined in the Riverside Drive and Webster Avenue Corridor Study as a trail that would run along the north side of St. Joseph Street and would eventually connect the East River Trail in Bellevue, with the Fox River Trail
- The committee discussed how road reconstruction projects relate to pedestrian plans in the village (e.g. Riverside Drive crossings, St. Joseph Street facilities, Webster Avenue bridge)
- The bicycle and pedestrian facility recommendations shown on the maps in the plan:
 - Making connections with existing facilities
 - The Lebrun trail connection
 - Sidewalks on East River Drive
 - Sidewalks and crossings on Riverside Drive
 - Crosswalks in general throughout the village
